

This change without regulatory effect increases the maximum civil penalty for a violation of Business and Professions Code section 7110 from \$8,000 to \$30,000. This change is being made to align the regulation with Business and Professions Code section 7099.2, which was amended by Assembly Bill (AB) 1747 (Stats. 2022, Ch. 757).

OAL approves this change without regulatory effect as meeting the requirements of California Code of Regulations, title 1, section 100.
