Registrar Revokes Plumbing Firm's License

What began as a call to a plumbing company about a leaky commode wound up costing an elderly homeowner nearly \$7,000. The bill was mostly for unnecessary services that the contractor provided after persuading the customer that the drain pipes needed replacing because they were allegedly clogged and full of roots.

On October 17, 1984, the 72-year-old Southern Californian called the Los Angeles Police Department's Bunco Division to complain about her dealings with Martin Plumbing and Heating, Inc. of Highland Park. The LAPD's Bunco Division immediately responded to her complaint and contacted the CSLB's Special Investigation Unit. The pooling of these investigative and regulatory resources produced a thorough investigation and ultimately led to similar cases, resulting in the arrest of Michael Carr, owner of Martin Plumbing and Heating and two salesmen, Mark C. Ryder and William D. Ryder. The three were charged with multiple counts of conspiracy to commit grand theft, grand theft, attempted grand theft and bilking mostly elderly persons out of at least \$200,000. Each defendant pled guilty and bail was set at \$4,000 each.

As for the elderly homeowner, she was fortunate that her complaint led to the return of her money. But, nearly 40 other less fortunate consumers fell victim to the same sales tactics used by Martin Plumbing sales agents. In one instance, an 83-year-old man nearly exhausted his life savings—\$13,000—to pay Martin Plumbing for repairing clogged sewer lines. Ironically, the fixtures that leaked prior to the \$13,000 job continued to leak following the repairs. Another case involved an elderly customer who paid \$13,000 for a job that should have cost less than \$400.

In other cases, Martin Plumbing repair personnel "intentionally damaged plumbing under the guise of trying to locate a reported problem," according to Lt. Fred Reno with the LAPD. Martin employees would talk customers into major repairs by telling them that their pipes were broken. Martin employees would haul buckets of water to pour under homes and attribute the mud on their clothes to the alleged area of leakage.

"What began as an investigation into one

case mushroomed into an investigation involving multiple cases of fraud perpetrated mostly against elderly citizens by a single plumbing firm," stated Registrar Jack Maloney. Within six weeks of responding to the original complaint against Martin Plumbing, the situation had evolved into a slew of cases riddled with civil and criminal law violations involving safety hazards, poor workmanship substandard and unnecessary and overpriced repairs.

The ongoing investigation revealed that the company had also filed at least 40 liens on the victims' properties and was threatening several foreclosures. Because there were some victims who could lose their homes and there were others whose lives were endangered by safety hazards created by Martin Plumbing, the registrar felt compelled to take measures to protect the public from further abuse. The

CSLB and Local Sheriff Nab Nonlicensee

While the CSLB has endured severe staff reductions in prior years, it has developed a cooperative working relationship with local law enforcement agencies in various parts of the state. In particular, this investment of time has netted a profitable dividend for CSLB in that a mutual working rapport between the Fresno district office and the Fresno Sheriff's Department led to the arrests of Mike Lopez, an unlicensed contractor and his accomplice Mary Lopez. Both were allegedly doing business as Mike's Cabinet Shop and Golden Hammer Construction. Bail was set at \$12,000 each.

The CSLB and the Fresno Sheriff's Department has numerous complaints against Lopez. In 1983, Lopez was charged with contracting without a license and convicted of diversion of construction funds, a felony, and put on summary probation with an order to make restitution to the victims. Furthermore, in 1983, Lopez was denied a contractor's license on the basis of a prior complaint involving financial injury and for failing to complete work for which he contracted.

Despite this, Lopez resumed contracting without a license. But his luck ran out when CSLB received an anonymous tip about a job that Lopez was performing nearby. Fresno district office Senior Deputy Lonnie Painter

followed up on the tip and contacted Detective John Clark with the Fresno Sheriff's Department and Deputy Richard Rivera of CSLB's Special Investigations Unit to set up a sting operation.

On Wednesday, April 3, 1985, an undercover officer posed as a homeowner asking Lopez to do some cabinet work, cement repair and roofing. Lopez prepared a contract for \$2,400 and asked for half of the money as a down payment. Rivera arrested the Lopezs at the undercover house provided by the Fresno Sheriff's Department.

Numerous felony and misdemeanor charges were filed against the Lopezs. The charges include conspiracy to commit grand theft by fraud, misappropriation of construction funds, attempted grand theft and contracting without a license. In addition to these charges, the Lopezs were also charged with violating Section 7026.10, willful and fraudulent use of a license—a new section of the Contractors License Law.

Registrar Jack Maloney expressed concern over the financial injury caused to homeowners and added that stepped-up enforcement efforts such as sting operations in the Fresno area could conceivably make it harder for nonlicensees to operate openly and actively.

Industry Experts Help CSLB

The Contractors State License Board has initiated a pilot project which could result in quicker closure of complaints.

Titled the "Expert Consultant Program," the new venture proposes the use of industry experts to help streamline the process of identifying and resolving cases where poor workmanship is alleged.

The evolution of this new program stems from a combination of reduced staff and an ever-growing complaint workload. CSLB staff members noted that most complaints were being screened and mediated by a consumer representative on a timely basis, but that backlogs were occurring because there were not enough deputies to investigate cases.

Further, it was noticed that a large portion of the complaints awaiting investigation alleged poor workmanship. Based on these facts, the notion of retaining experts to verify the workmanship was proposed.

The Expert's role is to review pertinent documents, make a site visit and submit a written report to the board. The board's staff then will decide if the case requires further action.

The assistance of the expert will quicken the process of identifying valid complaints and also allow the board to file actions when they are warranted. Based on statistics, the board's staff members believe that approximately 30 percent of current cases can be assisted by utilizing experts before an investigation is initiated.

This pilot attempt, which began earlier this year, will be tested for several months in the



San Francisco Bay area. For the test period, only swimming pool and home-remodeling complaints will be involved. If the program is successful, other trades will also be included.

To get the program underway, a meeting of a group of invited experts and board staff members was held. Board member Warren McNely noted the enthusiasm of the participants and thanked industry representatives for helping to solve an industry problem.

McNely summarized his feelings by stating that he "viewed the Expert Consultant Program as a service to the industry." Participants agreed that the program should be an asset to industry, consumers and the Board.

"I am pleased with the concept of the program because it encourages industry to work with the board in solving a mutual problem. If the pilot project is successful, I will seek to expand the program to other areas of the industry and state."

Contractor Jailed Trying To Get License

SAN BERNARDINO—A Pomona man who has been in trouble numerous times for contracting without a license was arrested here Monday when he arrived to pick up his application for a contractor's license, authorities said.

Falakesi "Casey" Makaafi Pine, who lives at 1790 W. Holt Ave., has twice pleaded guilty to contracting without a state license and is on probation for the offense.

He was arrested Monday on warrants issued after he failed to follow through on past cases in Pomona and Fontana, authorities said.

Pine was arrested at the offices of the Contractors State License Board on Second Street. He had gone to the license board's San Bernardino office at the request of the board, which had sent his application for a contractor's license here, said Tom Cavallo, deputy registrar of the board office.

Pine was taken to County Jail. Bail was set at \$3,100 for failure to pay a fine on a Fontana case of contracting without a license and for three failures to appear in court in Pomona on the same charges, a jail spokesman said.

According to records at the license board office, Pine was cited five times in 1984 for contracting without a license and was fined \$2,600 by the state.

Pine also pleaded guilty to misdemeanor charges of contracting without a license in

1983 in Riverside and San Bernardino municipal courts, Cavallo said.

In the San Bernardino County case, Cavallo said a cement company had put a lien on a Fontana couple's property because Pine had failed to pay the company when he finished the couple's job.

Cavallo said Pine pleaded guilty in the Fontana case. He paid a \$180 fine, was ordered to pay \$752 restitution to the couple and was placed on three years probation, Cavallo said.

Cavallo said the damages claimed by former customers of Pine came to about \$10,000. He did not know how much, if any, Pine has repaid.

In responding to this article, the Registrar commented that "Although the board's staff resources may not allow us to expend as many hours as are needed in the unlicensed contractor department, we have developed more creative and effective techniques in curbing some nonlicensee activity."

Roger Schneider, Supervising Deputy in the San Bernardino office was pleased with the outcome of the Pine case and hoped that "The arrest sent a warning signal to the nonlicensees in San Bernardino and a strong message to the consuming public to beware before they contract."

New CSLB Chairperson And Vice-Chairperson Elected

At its July 1985 meeting, the Contractors State License Board unanimously elected Frank Geremia, Jr., as Chairperson and Benny Y. Yee as Vice-Chairperson for the 1985-86 year.

Geremia, who has been a member of the Board for two years, was the chairperson of the Enforcement Committee from 1984 to 1985 and was a member of the Licensing Committee in 1983.

Geremia, a C-53 contractor, is president of Geremia Pools, Inc., in Sacramento. He is also the president of the California Swimming Pool Industry Council and was chairperson of the Sacramento National Spa and Pool Institute from 1976-77 and represented seven western states on the National Board of Directors of NSPI from 1979-80.

Yee was appointed to the Board in 1982 and has since served as a member of the



Operations, Administration, Licensing and Enforcement Committees.

Yee is a real estate broker and president of Benny Y. Yee Associates Real Estate and



Development Company. In 1982, Yee was the director of the Time Savings Loan Association and the San Francisco Board of Realtors.

1983-84 Legislative

During the 1983-84 Legislative Session, many bills pertaining to licensed and (nonlicensed) California contractors were introduced and enacted. The following list describes major pieces of legislation that became law on or before January 1, 1985. AB 844 (Lancaster). Mechanics' Liens. Prohibits an owner or original contractor from waiving, affecting, or impairing the mechanics' liens claims of any other person, except by the person's written consent, and then only when the claimant executes and delivers a waiver and release which conforms to one of several specified forms depending upon the circumstances. These forms are available from trade associations and construction attorneys. Effective January 1, 1985.

AB 1994 (Tanner). Swimming Pool Contractors. Adds Section 7166.5 to the Business and Professions Code to define "swimming pool" to include any spa or hot tub which is permanently installed. Effective January 1, 1984.

AB 2069 (Tanner). Contractors. Revises various provisions of Contractors License Law: 1) Requires suspension of a joint venture license when any member does not have an active license in good standing; 2) prohibits the use of a namestyle that is inconsistent with the license held by a licensee; 3) revises requirements for notification of the disassociation with a licensee of any individual who was the qualifying individual for the license; 4) revises conditions for voiding an application for an original license, an additional classification or for a change of qualifier; 5) revises conditions for the cancellation of a contractor's license upon the death or disassociation of a licensee, or a partner or member or a licensed entity; 6) revises procedures for placing a license on inactive status; 7) revises notification requirements for a change in records of a licensee; 8) authorizes the refusal of a license to any personnel of a person whose license was revoked who had knowledge of and participated in the acts contributing to the grounds for revocation of the license; 9) makes it grounds for disciplinary action for a licensee to falsely sign in support of any applicant's experience qualifications; 10)

prohibits any person who was a qualifying individual on a revoked license from being associated with another licensee, whether or not the individual had knowledge of or participated in the acts for which the license was revoked; and 11) provides that a license may be renewed after the renewal date only where the failure to renew was due to excusable neglect. Effective January 1, 1984.

AB 3158 (Bradley). Amends Sections 7029, 7030, 7068.2, 7076, 7090, 7115, 7117.5, 7141.5, 7145 and 7153.3 and adds Sections 7090.1 and 7111.1 to the Business and Professions Code. **Contractors.** Revises Contractors License Law to provide: 1) automatic suspension of a joint venture license when any member does not have an active license in good standing; 2) a corporation license is cancelled effective as of the date the corporation dissolves, merges out of existence or surrenders its right to do business in the state; 3) all licensees to notify the registrar in writing within 90 days of any address change; 4) that an applicant for licensure is subject to specified disciplinary action if s/he violates specified provisions of license law; 5) that the failure to pay a civil penalty or to comply with an order of correction constitutes grounds for the denial of or refusal to renew, a license; 6) that the failure of, or refusal by, a licensee to respond to a written request of the registrar to cooperate in the investigation of a complaint against that licensee constitutes a cause for disciplinary action; 7) that the failure of specified licensees, applicants, or registrants to provide information or make available records constitutes a cause for disciplinary action; 8) that acting in the capacity of a contractor under any license which has been suspended for any reason constitutes a cause for disciplinary action; 9) that the registrar may grant the renewal of a license or registration which has expired, under specified conditions; 10) that if a licensee fails to return an application for the renewal of a license or registration as a home improvement salesperson, which has been rejected, within 90 days, the application and fee shall be

deemed abandoned and the licensee or registrant shall be required to reapply; and 11) authorization for the registrar to review and accept petitions from specified licensees who dispute the cancellation of their license or the invalidation of their applications. Effective January 1, 1985.

AB 3230 (Hannigan). Adds Section 140 to the Business and Professions Code. **Taxation: information: enforcement: tax amnesty.** Provides that any board authorized to take disciplinary action against a person who holds a license may take disciplinary action upon the ground that the licensee has failed to record and preserve for not less than three years, any and all cash transactions involved in the payment of employee wages by a licensee. Failure to make these records available to an authorized representative of the board may be made grounds for disciplinary action. In any action brought and sustained by the board which involves a violation of Section 140 and any regulation adopted specifying Section 140, the board may assess the licensee with the actual investigative costs incurred, not to exceed \$2,500. Failure to pay may result in revocation of the license. Any moneys collected pursuant to this section shall be deposited in the fund of the board. Effective January 1, 1985.

SB 886 (Petris). Contractors; attorney's fees and costs. Provides that where a contract provides for attorney's fees, the provisions shall be construed as applying to the entire contract, unless each party was represented by counsel in the negotiation and execution of the contract, and the fact of that representation is specified in the contract. Effective January 1, 1984.

SB 977 (Vuich). Contractors: state projects. Requires the registrar to certify that a contractor is licensed at the time a contract is awarded in all state projects involving federal funds. Effective January 1, 1984.

Session Summary

SB 1016 (Montoya). Adds Section 7042.1 to the Business and Professions Code. **Contractors: exemptions from licensure: energy conservation; report.** Prohibits, until January 1, 1991, gas, heat, or electrical corporations and their subsidiaries regulated as public utilities by the PUC from conducting work for which a contractor's license is required, except if the work is performed: 1) on the corporation's property; 2) through a contract with a licensed contractor; 3) for low-income citizens pursuant to a program authorized by order of the PUC; 4) in furtherance of the generation, transmission, or distribution of electricity, gas, or steam, provided that any such work performed within a structure and beyond a customer's utility meter is necessary to protect public safety or to avoid interruption of service; or 5) to comply with programs or procedures ordered or authorized by the commission not inconsistent with the objectives expressed in Chapter 984 of the Statutes of 1983.

Intent language from Chapter 984: It is therefore, the intent of the legislature that the PUC be given clear and explicit mandate to regulate the involvement of electrical and gas corporations in energy conservation development, and to ensure that the energy conservation industry develops in a manner which is competitive and free from the potential dominance of regulated electrical and gas corporations. Effective January 1, 1985.

SB 1044 (Lockyer). Adds Section 11752.5 to the Insurance Code. **Workers' Compensation.** Requires the workers' compensation rating bureau to make available any policy information contained in its records to the Department of Industrial Relations and any other governmental agency if the Insurance Commissioner approves the release of the policy information requested. Effective January 1, 1985.

SB 1468 (Robbins). Adds Sections 7026.10 and 7026.11 to the Business and Professions Code. **Contracting: contractor's license**

number. Provides that any person who willfully and intentionally uses, with the intent to defraud, a contractors license number which does not correspond to the number on a currently valid contractor's license held by that person is punishable by a fine, not exceeding \$10,000, or by imprisonment in the state prison, or in county jail for not more than one year, or by both the fine and imprisonment. This penalty is cumulative to the penalties available under all other laws of this state. Effective January 1, 1985.

SB 1597 (Stiern). Amends Section 7137 of the Business and Professions Code. **Contractors.** Authorizes the board to set fees for licenses in an amount not to exceed fees presently prescribed by law. Has practical effect of allowing fees to be lowered by regulation if the Board so wishes. Effective January 1, 1985.

SB 1838 (Montoya). Adds Sections 7066.5 and 7080.5 to the Business and Professions Code. **Contractors.** Provides that any person may obtain blank license application, renewal, or reinstatement forms from the Department of Consumer Affairs, or may cause to be printed forms used or approved by the registrar. Also provides that the board shall publicly post, on the day following acceptance of an application, the name and address of the applicant, every classification for which the applicant has applied, and the names and titles of all personnel who have signed the application. Effective January 1, 1985.

SB 2082 (Lockyer). Adds Section 7108.6 to the Business and Professions Code. **Contractors: dump truck carriers.** Requires all licensed contractors to pay all transportation charges submitted by a dump truck carrier, licensed and subject to regulation by PUC, by the 20th day following the last day of the calendar month in which the transportation was performed, provided that the charges are submitted by the 5th day following the last day of the calendar month in which the transportation was performed. Any

violation of this section constitutes a cause for disciplinary action under Section 7120, but does not constitute grounds for a civil action. However, Section 7108.6 shall not be construed to prohibit the bringing of a civil action under any other provision of law. Effective January 1, 1985.

SB 2093 (Lockyer). Amends Section 7042.5 of the Business and Professions Code. **Contractors licensing: exemptions.** Eliminates the automatic repealer of the provision which exempts public utilities operating under regulations of the PUC from Contractors License Law regarding construction, maintenance, and development work incidental to their own business.

Also exempts from provisions of Contractors License Law those activities of a cable television corporation subject to regulation by the PUC, except underground trenching by a cable television corporation within the public streets, other than that necessary solely for the connection of its distribution system to, or within the properties of, subscribers or potential subscribers. Effective January 1, 1985.

SB 2152 (Ellis). Amends Sections 7099.2, 7099.3, 7099.4, 7099.5 and 7099.6, of the Business and Professions Code. **Contractors: applicants for licensure: issuance of citations.** Provides authority to specifically issue citations to applicants for licensure for violation of Contractors License Law. Effective January 1, 1985.

SCR 64 (Lockyer). Consumer Affairs. Requests that each board and bureau within the Department of Consumer Affairs submit a report to the legislature on or before November 30, 1985, which includes the following: 1) the board or bureau's written policy and procedures for responding to complaints and inquiries received from the public, including licensees; 2) a detailed analysis, including volume and nature, of all inquiries and complaints received by the board or bureau during fiscal year 1984-85 which are determined to be beyond the jurisdiction of the board or bureau; and 3) the board or bureau's written policy and procedures for responding to complaints involving unlicensed practitioners. Resolution Chapter 98, 1984.

State Establishes Mandatory Safety Program

Now there is even more reason to enforce your safety program. The administrative law judges and the Appeals Board have established five elements necessary for you as an employer to defend against unsafe independent employee actions.

Recognizing that some employees may act against their employer's best safety efforts, the Appeals Board has developed this test. As an employer you must show all of the following:

1. that the employee was experienced in the job being performed.

2. that you as the employer have a well-divised safety program which includes training employees in safety matters relating to their individual job assignments.
3. that you effectively enforce your safety program.
4. that you have and enforce a policy of sanctions against employees who violate your safety program, and
5. that the employee caused a safety infraction which he or she knew was in violation of your safety requirement.

A good safety program, properly enforced, with up-to-date records, can do a great deal to protect you from unexpected legal actions. An accident prevention program not only makes good sense, but is also a requirement of all California employers, who must "inaugurate and maintain" an accident prevention program for their employees.
